<b>1.</b>	<b>Competition name:</b>	Spend and Win
<b>2.</b>	<b>Promoter’s details:</b>	This Competition is conducted and organized by Stoneridge Centre (“ <b>Centre</b> ”) and offered by Redefine Properties Ltd (Registration Number: (1999/018591/06) (“ <b>Landlord</b> ”). In these T’s & C’s, we refer to the above promoter as “the Landlord” and the entrants as “the Participant(s)” or “you”.
<b>IMPORTANT INFORMATION</b>		
<b>3.</b>	<b><u>Eligibility:</u> Who may enter the Competition?”</b>	To enter the Competition a participant (“ <b>Participant</b> ”) must be in possession of a <b>valid South African identity document or passport</b> . Spend an R1000 or more, slip/s need to be added to the physical entry form located in prime spots in the Centre, Entries must be for one date only. All questions must be answered or it’s an automatic disqualification. T’s & C’s Box must be ticked or it’s an automatic disqualification.
<b>4.</b>	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, service provider, employee, agent, consultant, tenant of the Landlord at the Centre, the marketing service providers, and/or any person who directly or indirectly controls or is controlled by this entity, including their spouses, life partners, business partners or immediate family members.
